

The awarding of UC San Diego Division of Extended Studies academic credit for courses is approved in accordance with the regulations of the Academic Senate of the University of California. UC San Diego Division of Extended Studies operates on a **quarter system** and all credit is awarded in quarter units. Each quarter unit equates to two thirds of a semester unit and approximately ten hours of direct faculty instruction.

ACCREDITATION

UC San Diego is accredited by the Western Association of Schools and Colleges (WASC) Senior College and University Commission (WSCUC). UC San Diego Division of Extended Studies is accredited by WSCUC through the University. All courses and certificate programs offered by UC San Diego Division of Extended Studies have been developed and are administered in accordance with Extended Studies policy, the regulations of the Academic Senate of the University of California, and WSCUC standards.

CONTINUING EDUCATION UNITS (CEU)

The CEU is a uniform measure of a non-credit continuing education learning experience. Grades are not issued in accordance with the standards established by the International Association of Continuing Education and Training. One CEU is awarded for every ten contact hours of classroom instruction.

GRADE POINT AVERAGING

The current grading system became effective in the spring quarter, 2001. Prior to this term, grade point averages were not calculated.

TRANSFER OF CREDIT

UC San Diego Division of Extended Studies is not a degree-granting institution. The school or college in which students are registered determines the applicability of UC San Diego Division of Extended Studies courses to their degree programs. Students must check with the receiving institution for transferability.

COURSE PREFIXES

Course prefixes identify the type of course completed. Courses completed prior to fall 1994 do not include a prefix.

X – UC San Diego Division of Extended Studies courses not equivalent to UC San Diego courses, but which may have credit value.

XSD – Accepted for unit and subject credit for all requirements of specific University of California departments, schools, and colleges, as well as for general University requirements, if the corresponding regular course on the corresponding University campus is normally accepted.

XSDC – Offered as part of the concurrent enrollment program. Concurrent courses shall be offered and supervised by appropriate University departments, and credit is accepted toward unit and subject degree requirements. For courses to apply toward a higher education degree, credit is subject to the approval and regulations of the campus Graduate Council concerned.

COURSE LEVELS

1-199 – Courses structured and approved in accordance with the requirements for lower division (1-99) and upper division (100-199) UC San Diego level courses.

200-299 – Graduate-level courses offered as part of the University Concurrent Enrollment program.

300-399 – Professional credit-bearing courses in the field of education, specially designed for teachers and prospective teachers seeking credentials, authorizations, or other types of certifications in the State of California through the California Commission on Teacher Credentialing (CCTC). Major emphasis is on pedagogy, teaching methods and materials, and curriculum design. Credit in these courses is designed for professional upgrading, in-service education requirements, and basic and specialized credentials in the State of California; it may also lead to the award of a formal certificate by UC San Diego Division of Extended Studies. Credit may be applied toward an academic degree; preliminary teacher credentialing program in California, or requirements for licensure in other states, subject to the approval of the receiving institution(s). This course level is presented as the 30000 level in Extended Studies promotional material and My Extension.

400-499 – Post-Baccalaureate, professional-level, credit-bearing courses designed to provide opportunities for professional advancement and enable the general public to gain knowledge in various academic fields. Credit earned in these courses may lead to the award of a formal certificate by UC San Diego Division of Extended Studies or be applied toward an academic degree or professional credential, subject to the approval of the receiving institution.

800-899 – Non-credit, Continuing Education Unit (CEU) bearing courses designed for students seeking hours of instruction for career placement or advancement, or the opportunity to develop cultural, intellectual, and civic interests. This course level is presented as the 80000 level in Extended Studies promotional materials and My Extension.

900-999 – Non-credit-bearing, precollege-level courses designated to provide an opportunity for students to explore academic interests or prepare for college admission. Courses may be transferable for secondary school credit at the discretion of the receiving institution. This course level is presented as the 90000 level in Extended Studies promotional materials and My Extension.
