#### Course Timeline

Participants have one year to complete the course. Participants must spend a minimum of three weeks in this course.

## **Course Description**

Are you concerned about the bullying epidemic? Are you seeing more and more instances of bullying at your school? This online course is designed to help teachers understand the myths, facts, research, and current events that surround the topic of bullying. Teachers will be introduced to the most common types of bullying behaviors and become familiar with the various roles involved in bullying. Predictors and contributing factors, as well as assessment and identification of bullying will also be shared. Teachers will also learn about the effects that bullying has on learning in both the short term and the long term. Strategies will be covered to help teachers effectively assess, prevent, and reduce bullying, both in the classroom and throughout the school. Teachers will understand how to properly intervene during incidents of bullying, and they will learn how to develop and implement a variety of activities which are designed to put an end to bullying in the classroom. Teachers will also learn how to integrate character education into their content lessons, as well as how to partner with parents in an effort to end bullying. By the end of this course, teachers will feel empowered to handle bullying in the classroom and school.

- 2. Teachers will understand the scope and types of bullying.
- 3. Teachers will learn the roles involved in bullying.
- 4. Teachers will learn how certain social factors can contribute to higher rates of bullying.
- 5. Teachers will learn how to work with students, parents, and the school to share in the responsibility of addressing and reporting bullying.
- 6. Teachers will develop a deep understanding of cyber bullying and how to use the Internet to combat cyber bullying.
- 7. Teachers will learn the immediate and long-term effects bullying has on students.
- 8. Teachers will read about real-life stories where bullying played a powerful role in affecting the lives of students.
- 9. Teachers will understand how bullying impacts learning and how to identify students who are involved in bullying.
- 10. Teachers will learn how to create a positive and safe learning environment.
- 11. Teachers will be introduced to the anti-bullying laws and policies in their state.
- 12. Teachers will learn how to develop plans for bullying intervention.
- 13. Teachers will understand the relationship between bullying and character education.
- 14. Teachers will learn how to work with parents to help students recover from bullying.
- 15. Teachers will be introduced to specific bullying management activities that can be used in the classroom.
- 16. Teachers will review an extensive list of online resources containing bullying information, lesson plans, and videos.
